The Pima County Regional Wastewater Reclamation Department and its contractor B&F Contracting, Inc., are continuing work on the North Rillito Interceptor (NRI) sewer pipe rehabilitation. The project is being completed in phases, with the next phase scheduled to start in early November 2016. The construction boundaries are from Pantano Road to Sabino Canyon Road and generally follow the Tanque Verde Creek alignment (see map on reverse). There will be temporary access changes to some residential areas.

Although some excavation will be required, most work will utilize the Cured-In-Place Pipe (CIPP) lining method.* Through this process, a resin-saturated lining is inserted into existing 15-inch to 36-inch sewer pipes. The lining is then cured with hot water. This process allows the saturated material to harden and adhere to the inside of the pipe, resulting in a "pipe within a pipe."

* However, there will be some open cut trenching and pipe replacement along the southern end of Lodge Road.

This trenchless technology allows the contractor to **rehabilitate the existing sewer pipes "in place"** rather than the traditional replacement method requiring extensive excavation and replacement of existing pipes, causing extended disruption to streets and surrounding neighborhoods and businesses. When completed, the NRI rehabilitation project will increase the lifespan of the sewers up to fifty years and minimize the number of sewer overflows.

In addition to the CIPP lining process, the contractor will **re-construct/rehabilitate the sewer manholes** along the alignment. Reconstruction efforts may require excavation in order to safely rebuild the manhole structure.

Motorists, pedestrians and cyclists traveling through the work area should be alert for large equipment, possible lane restrictions and detours in the work area.

Weekly construction meetings are open to the public and individual concerns can be addressed at these meetings.






