**Traffic Alert
Mabel Street Sewer Improvement Project**

Hunter Contracting Co., under contract with Pima County Regional Wastewater Reclamation Department (RWRD), is continuing with construction field activities on the Mabel Street Sewer Improvement Project.

The traveling public should anticipate the following:

Mabel Street East of Stone Avenue:

Beginning at 6 a.m. Monday, November 9 through 5 p.m. Friday, November 13, the center lane of Fifth Avenue will be closed from Mabel Street to Drachman Street.

The closure is in place to safely accommodate the placement of a temporary sewer bypass system. The following restrictions will be in place during this work:

- Mabel Street will be closed at its intersection with the east side of Fifth Avenue.
- Eastbound turn movements from Fifth Avenue to Mabel Street will not be permitted.
- Turn movements from Eastbound Mabel Street to northbound Fifth Avenue will not be permitted.
- East and westbound Mabel Street through travel at Fifth Avenue will not be permitted.
- North and southbound travel on Fifth Street is not impacted by this work
- Emergency access will be maintained.

On Tuesday, November 10, the Sixth Avenue center turn-lane will be closed at Mabel Street while the contractor completes manhole rehabilitation work. **This lane restriction will be in place through November 13, 2020.**

- North and southbound Sixth Avenue traffic will be shifted around the work area.
- Through-travel and left-turn movements from Mabel Street will not be permitted.

Mabel Street is closed to all vehicle and bicycle traffic **at the intersection of Sixth Avenue while the contractor installs new sewer lines.** This closure will remain in place 24-hours per day through **Tuesday, November 10.**

- North and southbound Sixth Avenue at Mabel Street will be shifted and reduced to one travel lane in each direction.
- Westbound turn movements from Sixth Avenue to Mabel Street will not be permitted.
- Westbound Mabel Street through-travel at Sixth Avenue will be required to detour north or southbound at Sixth Avenue.
- Left turn movements from southbound Sixth Avenue to Mabel Street are permitted, however, there will not be a dedicated center left-turn lane at Mabel Street during this work.
- Pedestrian access will be maintained.

The contractor continues with excavation and installation of new sewer pipe along Mabel Street east of Stone Avenue. The following restrictions will be in place through approximately mid-November 2020.

- Eastbound turn movements from Stone Avenue to Mabel Street are permitted.
- Access to Stone Avenue from Mabel Street will not be permitted.
- Mabel Street between Stone and Sixth avenues will be closed to all but local traffic.
- Access to businesses on Mabel Street will be maintained.
- North and southbound access on Seventh Avenue at Mabel Street will be maintained.
- Vehicle, pedestrian and bicycle travel on Stone Avenue will not be impacted by this work.

Mabel Street West of Stone Avenue

The contractor is also continuing manhole and 12-inch sewer line installation along Mabel Street between Main and 11th avenues.

- Mabel Street between Main and 11th avenues will be open to local traffic only.
- The contractor will work from 7 a.m. to 3 p.m. each day, however, the traffic control/lane restriction will remain in place 24-hours per day.
- This section of work is scheduled for completion by mid-November 2020.

The project includes the installation of new sewer line and manholes along Mabel Street between 13th Avenue and 6th Avenue. The traveling public will see heavy equipment, work crews and traffic control during this project. Construction is scheduled to be complete by the end of 2020.

Because of the extensive work and excavation required, portions of Mabel Street will be intermittently CLOSED in the area of work. Access for local traffic and emergency response will be maintained.

The schedule is subject to change due to inclement weather or unforeseen circumstances. For your safety, please observe all traffic control, message boards and reduced speed limits.
