**Traffic Alert
Mabel Street Sewer Improvement Project**

Hunter Contracting Co., under contract with Pima County Regional Wastewater Reclamation Department (RWRD), is continuing with construction field activities on the Mabel Street Sewer Improvement Project.

The traveling public should anticipate the following:

Mabel Street East of Stone Avenue:

On Tuesday, November 24 and Wednesday, November 25, from 7 a.m. to 3 p.m. each day, the contractor will pave portions of Mabel Street and Sixth Avenue that were disturbed during the sewer improvement project. The traveling public should watch for the following restrictions:

- **Tuesday, November 24, 2020 from 7 a.m. to 3 p.m. the contractor will pave the westbound lane of Mabel Street from Sixth Avenue through Seventh Avenue.**
 - Southbound Sixth Avenue traffic at Mabel Street will be shifted into the center turn lane.
 - Through-travel and left-turn movements from Mabel Street at Sixth Avenue will not be permitted.
 - Right-turn movements from southbound Sixth Avenue to Mabel Street will not be permitted.
 - Flaggers will be on site at the intersection of Seventh Avenue and Mabel Street to help direct traffic around the paving operation.
 - Pedestrian access will be maintained.
- **Wednesday, November 25, 2020 from 7 a.m. to 3 p.m. the contractor will pave the Sixth Avenue center turn lane at Mabel Street and the westbound lanes of Mabel Street from Seventh Avenue to Stone Avenue.**
 - All left-turn movements will be restricted at the intersection of Sixth Avenue and Mabel Street from 7 a.m. to 3 p.m.
 - East and westbound Mabel Street through travel at Sixth Avenue will not be permitted.
 - Vehicle, pedestrian and bicycle travel on Stone Avenue will not be impacted by the paving operation.

Mabel Street West of Stone Avenue

The contractor is continuing manhole and 12-inch sewer line installation along Mabel Street between 11th and 10th avenues.

- Mabel Street between 11th and 10th avenues will be open to local traffic only.

- The contractor will work from 7 a.m. to 3 p.m. each day, however, the traffic control/lane restriction will remain in place 24-hours per day.
- This section of work is scheduled for completion by early December 2020.

The project includes the installation of new sewer line and manholes along Mabel Street between 13th Avenue and 6th Avenue. The traveling public will see heavy equipment, work crews and traffic control during this project. Construction is scheduled to be complete by the end of 2020.

Because of the extensive work and excavation required, portions of Mabel Street will be intermittently CLOSED in the area of work. Access for local traffic and emergency response will be maintained.

The schedule is subject to change due to inclement weather or unforeseen circumstances. For your safety, please observe all traffic control, message boards and reduced speed limits.
